POLICY NAME: Micro-Credentials Policy

POLICY TYPE: Board

ISSUE OR STATEMENT OF PURPOSE:

To establish Micro-Credentials for SUNY Erie, with the intention of providing the College with additional recruitment tools and opportunities to assist students persist in achieving their educational goals.

POLICY:

SUNY Erie CC Micro-Credentials

Micro-Credentials at SUNY Erie are a collection of courses and/or experiences that help students develop and document professional skills and competencies. SUNY Erie recognizes two types of Micro-Credentials which are covered by this policy.

Curricular Micro-Credentials: Curricular Micro-Credentials involve one or more credit-bearing courses. These Micro-Credentials must be reviewed and approved through the regular process of curriculum approval.

Curricular Micro-Credentials may encompass credit-bearing clusters of courses and/or segments within credit-bearing courses that add up to fewer than 24 credit hours.

- 1. Curricular Micro-Credentials may be within a single disciplinary area, or interdisciplinary.
- 2. A curricular Micro-Credential may be recorded on an academic transcript, on a co-curricular transcript, and/or represented by a digitally verifiable badge.



POLICY NAME: Micro-Credentials Policy – **Continued**

Competency Badges: Competency Badges document the attainment of one or more discrete, assessable skills. They may be offered as components of one or more courses or through one or more non-credit-bearing experiential learning activities, or a combination thereof.

- 1. Competency Badges are not recorded on the academic transcript but may be represented by a verifiable digital badge on a co-curricular transcript or other online platforms (e.g., LinkedIn).
- 2. The digital badge must be clearly identified as a Competency Badge and must state the competency(ies) attained.

Faculty and/or departments will develop Micro-Credentials through a proposal process centralized in the New Curriculum Development Committee (NCDC) and College Wide Curriculum Committee (CWCC) which will convene a committee of faculty and staff to review and approve them. The NCDC & CWCC will report approved Micro-Credentials to the Senate Executive Committee.

Requirements for Micro-Credentials and Competency Badges:

- 1. Anyone who is eligible to take the required credit or non-credit courses/programs or engage in the co-curricular activities may earn a Micro-Credential.
- 2. Micro-Credentials and Competency Badges are awarded upon successful completion and petition by the student of the specific requirements for that credential.
- 3. Curricular Micro-Credentials and Competency Badges should have clear, measurable outcomes, assessments aligned to the outcomes, and evidence of mastery of the outcomes.
- 4. Micro-Credential or Competency Badge approvals will follow all existing SUNY Erie processes and procedures.
- 5. Micro-Credentials will be comprised of less than 24 credits for completion.
- 6. The department will create and maintain a Requirement Checklist for each approved Micro-Credential.
- 7. Fifty percent of required credits or seat hours must be taken through SUNY Erie Community College (not via transfer credit, testing, or experiential learning.)
- 8. Course substitutions must follow all current SUNY Erie policies.
- 9. A minimum grade of C- is required in all courses taken for the Micro-Credential with a GPA of 2.0 for the Micro-Credential program unless a higher minimum grade and/or GPA is specified.

Definition of Micro-Credentials and some highlights from SUNY's Micro-Credentials Task Force Report:

SUNY's Micro-Credential Definition:

Micro-Credentials verify, validate and attest that specific skills and/or competencies have been achieved and are endorsed by the issuing institution, having been developed through established faculty governance processes and designed to be meaningful and high quality.

Parameters:

Micro-Credentials may represent the content of credit or noncredit study; they may take the form of digital badge or micro-award, and can be offered online, on-campus, or a hybrid of both. Micro-Credentials may be specifically recognized by certain industries, in which case they may have the advantage of providing validation and attestation of industry-specified and frequently highly sought-after competencies. Each Micro-Credential awarded must be represented clearly and accurately, addressing associated costs, financial aid, transferability, and stackability toward a formal award(s).



POLICY NAME: Micro-Credentials Policy – **Continued**

Guiding Principles:

- 1. Academic quality is paramount for Micro-Credentials, and faculty governance participation is required.
- 2. Micro-Credentials are initiated locally, developed, and approved according to local campus policies and procedures, consistent with campus mission and strategic goals.
- 3. Micro-Credentials designed to meet market needs should be informed by current data from appropriate markets and align with relevant industry/sector standards.
- 4. Micro-Credentials can provide opportunities for industry/education connections and partnerships.
- 5. Micro-Credentials are inherently more flexible and innovative.
- 6. Micro-Credentials should be portable.
- 7. Micro-Credentials should be stackable.
